## FEATURE TOPIC: THESEUS SUMMER SCHOOL 2015

Combining theory and practice: From 22 to 26 June 2015, the THESEUS Summer School 2015 invited 20 international students and young researchers to discuss the topic "Justice, Security and Liberty: Conflicting Goals?" with renowned experts at the Fondation Universitaire in Brussels. The highlight for many students was the final moot court exercise, which is a simulation of a court procedure at the European Court of Justice (ECJ).

During the first three days, the group listened to a series of lectures depicting different aspects of the topic. The renowned speakers came from



the fields of politics and law, working in various parts of Europe. THESEUS Resident Researcher Dr Sarah Leonard, University of Dundee, accompanied the seminar during the whole week. She raised the partici-

pants' attention for central questions of European security policies and asked them, what impression they had on the importance of security in EU politics. Carsten Kalla, University of Bonn, spoke about the "perplexities" of freedom, illustrated by the problem of handling data retention between regulations of EU law and national law. for Counter-Terrorism (ICCT) in The Hague, focused on the topic of counter-terrorism policies, and Dr Leonhard den Hertog, Centre for European Policy Studies (CEPS), and Dr Yves Pascouau, European Policy Centre (EPC) both in Brussels, closed the lecture part of the summer school with their speeches on EU migration and asylum policies.



The moot court was the summer school highlight for many THESEUS summer school participants.

After having discussed the many facets of the summer school topic, the last two days were left for the students and young researchers to apply their knowledge and to dive into the process of judicial decision-making. The simulated case dealt with the admissibility and validity of the Directive on data retention 2006/24/EC, which was defined invalid in the simulation due to its violation of fundamental rights.

"For me as a political scientist, the moot court was one of the most interesting aspects in my student life so far", said Political Science student Fabian Rohde. Julie Schäfer studies Law at the University of Cologne. The moot court was a new and interesting experience for her. "The intercultural and different subjects that we are studying contributed to two spectacular simulation days, although the co-working between political science and law students was not easy", explained Julie. She, as well as the other participants, want to recommend the summer school participation to her fellow students.

## THESEUS EUROPE@WORK 2015 - Paris & Brussels

"European Energy and Climate Policy" was the topic of the Europe@ Work Seminar 2015. 30 international master students from the fields of politics and economics met in Paris and Brussels from 8 to 12 June to visit numerous crucial institutions and discuss the topic with involved decision-makers and experts.

The group got detailled information about the development and aschallenges of European sociated Energy Policy, including risks of market stability, energy prices, the Emissions Trading System (ETS), benchmarks to reduce CO2-Emmissions, the cooperation between member states and incentives for investors. Among the visited institutions were the company Electricité de France, the Organisation for Economic Cooperation and Development (OECD) and the International Energy Agency (IEA), the European Union Institute for Security Studies (EUISS), the European Climate Fondation (ECF) and the European Commission. The students came from the University of Cologne, the Turkish-German University (TDU) and Charles University in Prague.

The Europe@Work Seminar 2015 was closed with a roundtable discus-

sion on "European Energy Security: Consequences after the Ukraine Crisis. The Future Role of Turkey" on 9 July. The roundtable was chaired by Prof Wolfgang Wessels, University of Cologne. The panelists were Prof Atila Eralp, Middle East Technical University Ankara (METU) and Dr Harald Hecking, Institute of Energy Economics (EWI), as well as two students of Political Science and Economics from the University of Cologne. Dr Hecking spoke about the costs of energy supply and different international pipeline projects. Prof Eralp focused on the role of Turkey as important energy transit state. #### **INAUGURAL LECTURE**

How will the future of democracy look like? This is one of the central questions that the French scientist and THESEUS Visiting Professor Emiliano Grossman addresses in his research. In his inaugural lecture on 12 May 2015, he shared his reflections with students, scientists and interested citizens. "We have to analyse the relationship between supply- and demand-side of politics more closely and in new ways, if we want to understand the contemporary political economy", stated Grossman, speaking about politicians and voters.

He criticized a supply side focus in politics, which "arises from the understanding that citizens have to adapt to available political options", said Grossman. "This system does no longer function." In his view, voters have become more critical. "They are losing their trust in established parties partly also their political system." The consequence was that they voted for radical parties or that they no longer came to elections, a development which was further intensified through the current crisis letting people rethink the quality of their government. Grossman found that people above all looked at comparative government performance. "If the growth rate of a country [...] is slightly higher than that of its neighbour states, people are happy", summarised Grossman. A following reception invited the participants to further informal discussions.

## AWARD LECTURE

On 26 October 2015, Prof Loukas Tsoukalis. Hellenic Foundation for European & Foreign Policy (ELIAMEP), and Prof Wolfgang Streeck, former director of the Max Planck Institute for the Study of Societies (MPIfG,) will speak about possible shortcomings of European monetary integration at the Fritz Thyssen Foundation in Cologne. The lecture shall give the opportunity to discuss the strengths and weaknesses of monetary union, the present state of affairs, and Greece as a special case study. It also builds the floor to discuss the risks of disintegration more generally. At his awarding ceremony during the Latvian Pre-Presidency Conference on 4 December 2014 in Riga, the scientist explained that for him the European project has always been a symbol for "peace and open borders, democracy, economic development and inclusive societies in a continent confident in its diversity and proud not only of its past". In his research, he critically analyses the EU's development.
